A tax barrister can help you by drafting your statement and those of your witnesses. A tax barrister will often work on the basis of a fixed fee, helping you to maintain closer control over your spending on legal costs. Top Class Advocates

Accomplished tax specialists could advise on contracts such as wills. SDLT implications of corporate reorganisations and mergers including SDLT relief on intragroup transfers of property, reconstruction and acquisition reliefs on demergers of property and alternative structures where reliefs are not available is an area of expertise for a tax barrister. How we tax, who we tax and why we tax determines what kind of society we become, giving financial expression to our cultural values and priorities. Far from being dry and dusty, taxation is a topic that could not be more political. Tax barristers' core areas of expertise are private client IHT and CGT, VAT, employment-related taxes, corporation tax, tax penalties, and property-related taxes. There is perhaps a perception in some smaller professional practices that seeking assistance from a tax barrister is unsuitable for them, on the basis that instructing tax counsel is the domain of the Big 4 accounting firms or Magic Circle law firms with detailed and complex tax issues. The opinion of a Pensions Advice service should be sort if clarification of the finer issues are required.

A barrister who is an expert on tax matters can provide advice to clients on the annual tax on enveloped dwellings. Tax barristers work alongside private client

lawyers on matters of private wealth. A tax dispute expert can be engaged on professional negligence claims in respect of tax matters, and other claims or disputes which include elements of tax or tax consequence. Whatever the nature of the dispute, by becoming involved at an early stage and by providing bespoke advice, they are able to offer support and solutions to manage the outcome. Competent barristers can give counsel on tax investigations. If you and your solicitor decide to involve a barrister in your case, the solicitor will send the barrister a brief containing all the relevant information and documents to assist the barrister in the presentation of the case. Specialist assistance for Tax Barrister should be sought whenever required.

Good At Explaining Complex Issues

The best tax barristers advise corporate clients, insolvency practitioners, government bodies, trustees, charities and not-for-profit organisations. Barristers regularly undertake privately funded, direct access and legal aid work. Some UK tax barristers are qualified to practice in New York, Canada, South Africa and the Republic of Ireland. The practice of a tax specialist can cover all forms of (direct and indirect) contentious tax matters, including: tax litigation and ADR; HMRC enquiries and compliance checks; HMRC civil information powers; tax offences and serious investigations; voluntary disclosures and penalty mitigation; and commercial tax disputes. Unlike some tax professionals which specialise principally in tax litigation (both statutory appeals and judicial review), some tax barristers have experience in advising both on the implementation of tax related matters and in the defence and challenge to tax matters before the tribunals and higher courts. Advisory services such as Domicile Advice are a common sight today.

Multi-disciplined tax barristers are experienced in advising banks, companies and funds on all types of finance arrangements and insolvency law. The expertise of a tax barrister can be invaluable in dealing with arguments in an increasingly complex area of law where courts and tribunals are often hostile to the taxpayer. A barrister with expertise in real estate tax can give advice in relation to restructuring advice to non domiciliaries and non-UK trusts owning (in each case) UK real estate.
